**Rules and Regulations**

1. Boat Mooring fees are \$799.69 for WSPOA Residents, granting 1 boat slip. Jet skis will be granted ½ boat slip at the cost of \$597.10 for WSPOA Residents.
2. All non-motorized watercraft (*canoes, kayaks, row boats, etc*) will be stored in a designated area on the beach at a cost of \$79.97 each.
3. All docks will be assigned contingent upon full payment of (2026 membership dues WSPOA), Mooring fees, valid insurance, and registration, along with a signed copy of the 2026 Boating letter (*attached*)
4. All toys and small beach items must be in a dock box (\$79.97), not left on the beach. A sticker will be provided and must be visible. All items left on the beach and not in a dock box will be removed and discarded.
5. All members must comply with WSPOA by-law regulations and all NJ Marine Safety Regulations.
6. Boats that do not conform to WSPOA by-law requirement (19ft length, 75in width) assigned as space allows.
7. All boats and watercraft must be secured to the dock/catwalk. Securing to another boat is strictly prohibited. Permanent ropes tied to the dock for the season are strongly recommended.
8. All boats, trailers, etc. left on the beach or WSPOA property will be removed at the owner's expense.
9. All boats are to be moored in assigned spaces. No Subletting is permitted.
10. All boat stickers must be adhered to the right side of the boat where visible, subject to a warning/\$100 fine/or loss of slip for the 2026 season.
11. No boats/watercraft are to be in the swimming area at any time.

**ANY VIOLATIONS OF THE RULES AND REGULATIONS  
THE BOAT/JET SKI OR ANY WATERCRAFT WILL BE REMOVED/TOWED AT THE OWNERS EXPENSE  
AND ALSO LOSE THEIR SLIP FOR THE 2026 BOATING SEASON**
